Solidly documented, it is probably the first complete historical and legal analysis of the Nuremberg trial and, in view of the nature of the subject, should be considered a book of enduring importance.

About the Author

Whitney R. Harris was educated at the University of Washington (B.A., 1933, magna cum laude) and at the University of California (L.L.B., 1936). He entered the U.S. Navy in 1942 and rose to the rank of Lieutenant Commander, receiving the Legion of Merit for his work on the staff of Justice Robert H. Jackson, Chief Counsel at the Nuremberg war trial. At the conclusion of the trial he was transferred as legal advisor to General Lucius Clay, the United States Military Governor for occupied Germany. In 1948 Mr. Harris reentered civilian life as a professor of law at the Southern Methodist University. He subsequently was Executive Director of the American Bar Association and a practicing lawyer in Dallas, Los Angeles and St. Louis.
